The Civitas Resources insurance program includes Excess Liability coverage of \$110,000,000 per occurrence and in the aggregate which sits over the sudden and accidental pollution within the General Liability coverage. Proposed Soil Sampling:

Grab confirmation soil samples will be collected from beneath the above ground oil tanks, cement water pit, separators, wellheads, and flowline start/end points. Potholes will be dug every 250 feet along the flowline path. These observation points will be photographed and field screened. Additional soil samples will be collected when flowline repairs are observed, changes in flow direction, or when there is a change in the flowline material type. A grab confirmation soil sample will be collected from the center of the cement water pit footprint, or areas of observed impact based on visual and olfactory observation. A minimum of four sidewalls and the base will be field screened. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
