Comment:

A vegetation transect was completed to compare revegetation within the project area to vegetation within a nearby reference population. Revegetation along the transect within the well pad area was 96 percent of vegetation along the reference area transect.

Vegetation transects show that location has met final reclamation vegetation standards, however, remediation project on location (project #19324) remains active. Location cannot receive a final reclamation status until all remediation projects on location are closed.

Operator remains responsible for monitoring and managing this site until the location passes final reclamation, including storm water and weed management.
