**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation was conducted pursuant to ECMC Rule 911 at the ENGLAND RYDGREN T4N-R64W-S8 L01 Tank Battery location. On 11/11/2021, the tank battery was decommissioned in accordance with ECMC rules. Laboratory soil samples were collected from the partially-buried produced water vessels' (PWVs) excavations (FS01 & FS03) and field screening samples were taken from the sidewalls of the excavation adjacent to each vessel (SS01-SS04 & SS09-SS12). The screening samples with the highest PID (SS01@2.5' & SS09@2.5') were collected for laboratory analysis. Laboratory soil samples were also collected from beneath the above ground storage tanks (AST01 & AST02) and beneath the the separator risers for the dumplines (SEP01-DL01 & SEP01-DL02) and the flowlines (SEP01-FL & SEP02-FL). Additionally, field screening samples were collected beneath the flares (FLARE01) and meter houses (MH01 & MH02).

Soil samples were collected as described in the Initial Action Summary of this Supplemental Form 27. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
