Historical impacts were discovered during flowline decommissioning activities at the flowline wellhead riser where the PID was 0.1 PPM. Due to the historical nature of the release, an exact cause was not able to be identified.

PDC conducts routine AVO inspections of all oil and gas flowlines in order to identify and mitigate potential releases. Further, this flowline is no longer active and is in the process of being decommissioned. The flowline has been taken out of service and there is no longer a possibility of a release originating from this infrastructure.
