Drill cuttings remain stored within the cut along the northeast ends of the Location. Pursuant to Operators Form 2A Location Permit #402609514, cuttings are to be disposed offsite; Remediation of drill cuttings / cuttings management is not interpreted as part of "drilling or subsequent operations", per the "NTO: Interim Reclamation Procedures for Delayed Operations".  
  
Pursuant to Rule 1003.a, interim reclamation is due by 7/22/2025. A follow-up inspection will be performed to determine compliance with 1003 timing requirements.
