Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

On 3/27/2025, HANSCOME C21-20 flowline decommissioning activities were completed. During the completion of the activities, no potential presence of impacted material(s) was observed/smelled. Consistent with Rule 912, samples were collected and analyzed to determine whether any constituents are present at levels in excess of Table 915-1 standards. Final laboratory analytical results received on 4/10/2025 indicate that soil sample FL01-03, discovered along the flowline, exceeded ECMC Table 915 standards for naphthalene at 0.212 mg/kg, benzo(a)anthracene at 0.541 mg/kg, benzo(a)pyrene at 0.348 mg/kg, benzo(b)fluoranthene at 0.469 mg/kg, 1-methylnaphthalene at 0.0433 mg/kg, and 2-methylnaphthalene at 0.0741 mg/kg. Groundwater was not encountered during flowline decommissioning activities. This is located within 300 feet of surface waters of the state. A supplemental Form 27 has been submitted for remediation project number 34830 detailing the remedial site plan, document number: 404161747.
