INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the HSR-ALBERSTEIN 16-23 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. Approximately 600' of flowline was removed.

Five (5) grab soil samples were collected at the wellhead excavation (1), flowline directional changes (3), and flowline terminus at the separator (1). Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for Table 915-1 compounds, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Previously, two (2) background samples were collected from similar lithographic soil near the wellhead (1) and near the flowline path (1) for EC, SAR, pH, boron, and ECMC Table 915-1 metals analysis. Residual metals at the site appear less than and/or consistent with background comparison and do not appear to warrant additional sampling.
The Operator's Environmental Consultant on this Site has changed and is conducting a thorough review of the project. Any required information, proposed additional investigation activities, reports, and addressing of COAs will be provided in Supplemental Form 27 submittals.
