INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the BROWN 44-24 wellhead cut and cap and flowline abandonment. Approximately 558' of flowline was temporarily abandoned-in-place due to field constraints. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is able to be removed. The wellhead was cut and capped per ECMC rules. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling will be conducted. Soil samples were and will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. Background soil samples will be analyzed by a certified laboratory for analysis of metals per ECMC Table 915-1 and soil suitability parameters including pH, EC, SAR, and boron. All sample analysis is performed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered, a grab groundwater sample will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, chloride and sulfate anions and total dissolved solids (TDS).

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Visual inspection of the wellhead and flowline areas occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The ECMC Flowline Closure and Wellhead Closure Checklists were utilized and filled out during the abandonment process. Photologs were attached with their respective site investigations.

One site specific background soil samples collected from approximately 2ft-bgs from one soil boring (BKG01) was submitted for analysis of pH, EC, SAR, and total metals (Table 915-1 List) by ECMC approved methods.

The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling will be conducted. Noble plans to conduct additional background soil sampling from at least three boring locations at similar depths and soil horizons as confirmation soil samples, in areas away from oil and gas infrastructure to further investigate residual inorganic concentrations in soil at the wellhead. The flowline was temporarily abandoned in place due to field constraints. Flowline decommissioning activities will be completed by another consultant and will be summarized in a subsequent Supplemental Form 27 submittal. Noble will complete the decommissioning of the site infrastructure as outlined in the approved Initial Form 27 (Document Number 403185177).

The implementation schedule has been changed due to the necessity for supplemental site investigation activities adjacent to the wellhead and the flowline.

OPERATOR COMMENT

Facility closure activities and confirmation soil sampling were conducted at the wellhead and flowline on June 7, and July 15, 2024, and were summarized in Supplemental Form 27 Document Numbers 403855233 and 403994786, respectively.

The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling will be conducted.

The flowline was temporarily abandoned in place due to field constraints. Flowline decommissioning activities will be completed by another consultant and will be summarized in a subsequent Supplemental Form 27 submittal. Noble will complete the decommissioning of the site infrastructure as outlined in the approved Initial Form 27 (Document Number 403185177).

Noble plans to conduct additional background soil sampling from at least three boring locations at similar depths and soil horizons as confirmation soil samples, in areas away from oil and gas infrastructure to further investigate residual inorganic concentrations in soil at the site.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
