## INITIAL ACTION SUMMARY

A site investigation will be conducted pursuant to ECMC rule 911 at the BROWN-61N68W/5NENW (336359) oil and gas location pertaining to the cut/cap of the BROWN 31-5 (05-123-24165) and BROWN 05-03 (05-123-19070) and decommission of the BROWN 31-5 and 5-3 Common Line (12324165,12319070\_FL) and decommission of on-location flowlines associated with BROWN 31-5 (05-123-24165) and BROWN 05-03 (05-123-19070). See site map exhibit for details.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

Grab confirmation soil samples will be collected from beneath the wellheads and flowline start/end points. Potholes will be dug every 250 feet along the flowline path. These observation points will be photographed and field screened. Additional soil samples will be collected when flowline repairs are observed, changes in flow direction, or when there is a change in the flowline material type. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

### Proposed Groundwater Sampling
