1. Project to remain under RSSL; groundwater expected to be greater than 100' with surface water being ~ 700' from site and 100' below location.
2. Reduced analyte suite of only Arsenic, SAR, and EC.
2a. EC added to reduced analyte suite because Spill 490251 is in same area and has EC exceedance. Cleanup will fall to worst impacts detected.
Backgrounds will be collected within native soils, Laramie thought background data was already collected by site, but not within close distance.
