One background soil sample was collected near the wellhead and analyzed for SAR. The soil sample was collected from a depth of 2 feet below ground surface (ft bgs). The maximum background concentrations for SAR was observed to be 0.244. All SAR concentrations observed during decommissioning were below background levels with the exception of soil sample WH-FS-01 @ 6'. Additional background samples (4+) will be collected and analyzed for metals and inorganics in soil per ECMC Table 915-1.
