Operator Comment: A sound level survey was performed by Behrens & Assoc. Inc., environmental noise control specialists, near the Pathfinder 1 production pad location (38.328927°, -105.178675°) in Fremont County, Colorado from Wednesday, June 18 to Thursday June 19, 2025, to measure and document the operational sound levels near the site and verify compliance with the applicable ECMC noise limits. See ATTACHED report that documents placement of decibel meters, procedure and findings by Behrens & Assoc. Inc. Behrens' Operational Compliance Sound Level Survey Conclusion is that the Pathfinder 1 Production Pad was in compliance with the extrapolated dBA and measured dBC Leq values throughout the measurement period per ECMC Rule 423. Based on the measured operational data at Locations 1 through 4, there were no noncompliant events.

Comment: Operator engaged Behrens & Associates, Inc., "Environmental Noise Control" specialists to conduct a 4 point sound survey throughout the Pathfinder Lease.
