INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the TIMBRO FEDERAL LD18-74HN wellhead cut and cap and flowline and gas line removal. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline and gas line at any points of material change and/or hammer unions, directional changes.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes. Confirmation soil samples will be collected from the final extents of the excavation at the wellhead. Soil samples will be/were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be/were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

If groundwater is encountered, a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Visual inspection of the wellhead and flowline areas occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The ECMC Flowline Closure and Wellhead Closure Checklists were utilized and filled out during the abandonment process.

Ten site specific background soil samples were collected from approximately 0.5 ft., 2.5 ft., 3 ft., 4 ft., and 5 ft-bgs from two soil boring (BKG01 and BKG02) was/were submitted for analysis of pH, EC, SAR, and total metals (Table 915-1 List) by ECMC approved methods.

Wellhead decommissioning activities and confirmation soil sampling at the Timbro Federal LD18-74HN wellhead occurred on September 12, 2024. Two confirmation soil samples were collected from the wellhead excavation (WH01@6) from approximately 6 feet below ground surface (ft-bgs) and from adjacent to the wellhead flowline riser (FLR01@4) from approximately 4 ft-bgs. One confirmation soil sample (FLR01@4) reported 1-methylnaphthalene (0.020 mg/kg) above the Table 915-1 ECMC GWSSLs and was reported as a historic release in Form 19 document number 403943228. Hydrocarbon impacted material at the wellhead will be removed and hauled to a permitted disposal facility. Final analytical results will be summarized in a subsequent Supplemental Form 27 submittal and will be reported along with ongoing Remediation Project Number 35388.
