Comments:

The former NRC 25-9 well (API: 05-123-30256) was never drilled according to Form 4 Document Number 2069234 received by ECMC on January 6, 2010. On May 15, 2025, KMOG conducted a final reclamation inspection for the permitted NRC 25-9 well pad (Location ID: 410187). The permitted well was never drilled, and the Document Number 2069234 was submitted on January 6, 2010. The inspection determined that the well was never drilled, and the land remains undisturbed from proposed activity with this well. KMOG used ECMC planned drilled coordinates to locate the well and photographed using drone photography. A general site location map is included as Figure 1; and the Site Map displaying the location of the Abandoned Location on aerial drone imagery captured on May 15, 2025, is included as Figure 2; Photographs of the AL location were taken facing each cardinal direction toward the AL wellhead location. The photographic log is included as Figure 3. Historic imagery from the date the permit was submitted to the date the Form 4 Abandoned Location was submitted are included as Attachments.

Based on the abandonment of this permit, a Form 4 Sundry Notice requesting final reclamation status has been prepared for submittal to the ECMC. This letter will be included as an attachment to the electronic Form 4 submittal. This is not intended as a submittal under the Operator Notice for Drone Imagery, but as a supplement to a standard Final Reclamation Completion Notice.
