On 07/11/2025 at approximately 12:14 hours, Compliance Inspector Dusty Popejoy conducted an on-site inspection/audit at UTAH GAS OP LTD DBA UTAH GAS CORP FOUNDATION CREEK B7406 PAD at Location ID #315085 in Rio Blanco County, Colorado.

This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, or Wildlife Management area.

During the inspection/audit, the following compliance issues were observed:

1. Equipment - Equipment has been modified and is not being operated in a safe manner with a CA date of 07/22/2025
2. Equipment - Unused flowline does not comply with CECMC 600 & 1100 series rules with a CA date of 07/22/2025
3. Equipment - Hole in separator building/wildlife hazard/available for entry by wildlife with a CA date of 07/22/2025
4. Signs/Marker - Wellhead sign lacks required information/not in compliance with CECMC rules with a CA date of 08/15/2025
5. Inspected Facilities - Well lacks wellbore diagram/not in compliance with CECMC rules with a CA date of 08/15/2025
