A site investigation was conducted pursuant to ECMC Rule 911 at the BOULTER T4N-R65W-S14 L04 Facility and Tank Battery location.

On 11/30/2023, grab confirmation soil samples were collected from the produced water vessel excavation (FS01@7', SS01@2.5', SS02@2.5', SS03@2.5, SS04@2.5'), beneath the ground oil tanks (AST01@0.5'), and at the risers for the flowlines and dumlines of any separators (SEP01-FL@3', SEP01-DL@3'). Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
