INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the PATRIOT B16-25 wellhead cut and cap and flowline removal. Approximately 305' of flowline was removed, however the remaining portion of the flowline was abandoned-in-place due to field constraints (Form 44 #403515255). The ECMC will be updated in a supplemental Form 27 if additional portions of the flowline are able to be removed. The wellhead was cut and capped per ECMC rules.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

The supplemental site investigation (SSI) proposed in approved Form 27 # 404171073 was completed on 07/07/2025 and 07/15/2025. Soil samples were collected to analyze for the full ECMC table 915-1 constituents at locations sampled during initial decommissioning (FS01@7', SS03@2.5', and FL01@3ft). Additionally, a hand auger investigation was completed to collect soil samples along the portion of the flowline which was previously abandoned in place, and to collect a flowline riser sample at the separator (FL01R-S@4-5'). Soil samples collected from proposed locations FL01-02, FL01-03, FL01-09, and FL01-10 were field screened only. Soil samples collected from proposed locations FL01-01, FL01-04, FL01-05, FL01-06, FL01-07, FL01-08, and FL01-11 were submitted for laboratory analysis of full ECMC Table 915-1 parameters.

Concurrently with the SSI, background samples were collected to determine if elevated pH is attributed to native soil conditions at the site and to determine a baseline for concentrations of metals and inorganic contaminants in native soil conditions at the site. All proposed flowline sample locations were selected based on the approved sampling map attached to the Form 27 Initial (ECMC Document #403152805). Analytical results for work performed on 07/07/2025 and 07/15/2025 are pending. Upon receipt of secured analytical reports, results will be summarized and additional supplemental investigation activities will be proposed as applicable.
