INITIAL ACTION SUMMARY

A site investigation will be conducted pursuant to ECMC rule 911 at the Edith Ann-Duckworth Facilities 21H-O268 (434303) oil and gas location pertaining to the removal of (3) separators. All other wells and equipment will remain active. See site map exhibit for details.

Grab confirmation soil samples will be collected from beneath the separators. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

The Civitas Resources insurance program includes Excess Liability coverage of \$110,000,000 per occurrence and in the aggregate which sits over the sudden and accidental pollution within the General Liability coverage.
