Corrective Action: Operator shall ensure discrete soil samples are collected from areas most likely to have been impacted using methods that minimizes contamination from sampling methods and handling that ensures the integrity of the sample. To prevent loss of volatile constituents prior to analysis, soil samples collected for laboratory analysis of volatile organic compounds ("VOC's") will be collected from soil representative site conditions - The soil surface will be scraped to remove weathered material to allow sample collection from freshly exposed material. In accordance with Rule 913.e.(3), Operator will adopt a quarterly reporting schedule (every 90 days) for Remediation Project #32355. The next Supplemental Form 27 is due on or before 9/15/2025.
