CECMC Inspection/Audit Report Summary

On 07/22/2025 at approximately 13:23 hours, Compliance Inspector Dusty Popejoy conducted an on-site inspection/audit at RETAMCO OPERATING INC PHILADELPHIA CREEK 13 PAD at Location ID #315196 in Rio Blanco County, Colorado.

This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, or Wildlife Management area.

During the inspection/audit, the following compliance issues were observed:

1. Equipment - Multiple holes in separator building open to wildlife/available for entry by wildlife with a CA date of 08/6/2025
2. Equipment - PRV vent line does not comply with CECMC pressure safety device rules with a CA date of 08/6/2025
3. Tanks and Berms - Multiple open ended piping on tank/wildlife hazard/available for entry by wildlife with a CA date of 08/6/2025
4. Housekeeping - Weeds/undesirable plant species surrounding production equipment constitutes a fire hazard with a CA date of 08/6/2025
5. Signs/Marker - Battery sign lacks quarter/quarter section information/not in compliance with CECMC rule with a CA date of 08/30/2025
6. Inspected Facilities - Well lacks wellbore diagram/not in compliance with CECMC rules with a CA date of 08/30/2025

A follow-up on this site inspection/audit will be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
