A site investigation will be conducted pursuant to COGCC rule 911 at the AMOCO-61S65W 17N2S2SE (320283) oil and gas location pertaining to the cut/cap of the AMOCO 44-17 (05-001-08859), decommission of production facilities, decommission of the AMOCO 44-17 (00108859FL) wellhead line, and decommission of all on-location flowlines. Ten grab soil samples were collected from the decommissioned facilities and two composite soil samples were collected from the stockpiled overburden. All soil samples were submitted to a certified laboratory for analysis of Table 915-1 metals and organic compounds, TPH C6-36, EC, SAR, pH, and boron.

If groundwater is encountered, a grab groundwater sample will be collected from the base of the excavation and submitted to a certified laboratory for analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, chlorides, sulfates, and TDS.
