On 07/24/2025, the potential presence of impacted material(s) was identified via hydrocarbon odor, and hydrocarbon staining during decommissioning activities at the Timmerman 14-13 wellhead, samples: WH01 & WH01-E, located at the wellhead in the same excavation. Final laboratory analytical data indicated a historical release was discovered at the Timmerman 14-13 decommissioned wellhead. CS-1, exceeded ECMC Table 915 standards for TPH at 657 mg/kg. WH01, WH01-E and CS-1 after review and discussion are being considered 1 release due to the close proximity to each other and that the only source area near by is the wellhead. The volume of potentially impacted material(s) is not currently known. Groundwater was not encountered during decommissioning activities.
