INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to CECMC Rule 911 a site investigation was conducted pertaining to the GREAT WESTERN KALLSEN tank battery. An initial site investigation and soil sampling event occurred on May 7th, 2024. Based on the laboratory analytical data from the confirmation soil sampling event, all constituents of concern from the Series 900 Rules Table 915-1 are below the regulatory standards or within background concentrations. The lower pH in samples appears to be de minimis and may not be associated with E&P activities. This Form is being submitted to meet quarterly reporting requirements. Site closure request is pending the removal of a third-party's equipment from the site.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Three (3) grab soil samples were collected at the former tank battery location. Soil samples were analyzed by a NELAP accredited laboratory for the full Table 915- analyses. Based on the laboratory analytical data from the May 7, 2024 confirmation soil sampling event, all constituents of concern from the Series 900 Rules Table 915-1 are below the regulatory standards or within background concentrations. The lower pH in samples appears to be de minimis and may not be associated with E&P activities.
