INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the Shable 21-20 wellhead cut and cap and flowline removal. Approximately 298 feet of flowline was removed, and a portion (626 feet) of the flowline was abandoned-in-place due to field constraints. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. A grab confirmation soil sample was collected at the wellhead excavation. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for full Table 915-1 organic and inorganic constituents in groundwater (Benzene, Toluene, Ethylbenzene, Total Xylenes (BTEX), naphthalene, 1,2,4-Trimethylbenzene, 1,3,5-Trimethylbenzene, Chloride ion, Sulfate ion and Total Dissolved Solids (TDS).

Visual inspection along the flowline and at the wellhead and separator areas occurred during abandonment activities. Field personnel field screened all disturbed areas using a PID, visual, and olfactory senses to determine if laboratory confirmation sampling was required. The applicable ECMC Closure Checklists were utilized and filled out during the abandonment process. A photolog was attached.

Per COA via document #: 403654569, the operator will return to the former Shable 21-20 flowline and collect samples along the abandoned-in-place (AIP) flowline. For additional details regarding proposed sampling along the AIP section of the Shable 21-20 flowline, refer to the attached document #403759174. Soil samples will be sent to a certified laboratory for analysis according to the full Table 915-1 analyte suite. All collected samples will undergo analysis by a certified laboratory using ECMC-approved analytical methods. Background samples will be used to support the justification for elevated concentrations.

In addition, the operator will re-sample and analyze soil at the FL03@3.5', FL01@5.0', and WH-FS-01@6' sample locations, at the same depths where the initial confirmation samples were collected. This re-sampling is intended to confirm the initial analytical results and obtain metal concentration data. Local background samples will also be collected to characterize native soil conditions. Noble will request a No Further Action (NFA) designation if the reanalyzed samples comply with the Table 915-1 concentration standard. Background samples will serve to justify elevated concentrations where applicable.
