Comment The location size has been reduced and it appears reclamation work was conducted at the wellbore area with evidence of crimped straw. Desirable perennial vegetation is present in the interim area however large patches of bare soil or lower vegetation coverage are also present. List B noxious weed musk thistle is present along the access road. See attached pictures.

Corrective Action Control weeds on location. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards.
