INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the OSTER 27-11G flowline removal. Approximately 339' of flowline was removed. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number was included previously under Related Forms.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Grab confirmation soil samples were collected along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods. A grab confirmation soil sample will be collected at the wellhead excavation in base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. The ECMC will be updated with the results of the wellhead decommissioning activities on a supplemental F27.

Proposed Groundwater Sampling

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for full Table 915-1 organic and inorganic constituents in groundwater (Benzene, Toluene, Ethylbenzene, Total Xylenes (BTEX), naphthalene, 1,2,4-Trimethylbenzene, 1,3,5-Trimethylbenzene, Chloride ion, Sulfate ion and Total Dissolved Solids (TDS).

Visual inspection along the flowline and at the wellhead and separator areas occurred during abandonment activities. Field personnel field screened all disturbed areas using a PID, visual, and olfactory senses to determine if laboratory confirmation sampling was required. The applicable ECMC Closure Checklists were utilized and filled out during the abandonment process. A photolog is attached.

Ten background soil samples were collected from an area not impacted by oil and gas development and at similar depths and lithologies as confirmation soil samples collected at the location and analyzed for Table 915-1 metals and SSR constituents. Background soil sample analytical results were reported with elevated levels of pH, Arsenic (As), Barium (Ba), Cadmium (Ca) and Lead (Pb).

In accordance with COAs issued via document numbers 403649317 and 403759278, the operator returned to the former Oster 27-11G flowline on 12/11/2024. A sample was collected at the previously field-screened directional change (Sample Location FL02) and analyzed for the full Table 915-1 analyte suite. The soil analysis showed no exceedances for ECOMC Table 915-1 organic compounds, Soil Suitability for Reclamation (SSRs), or metal concentrations, with results falling within the natural variability observed in the local background sample concentrations.

Additionally, the operator will re-sample and analyze soil at the FL01@5.0' and FL03@5.0' sample locations, at the same depths where the initial confirmation samples were collected. This re-sampling is intended to confirm the initial analytical results and obtain metal concentration data. Local background samples will also be collected to characterize native soil conditions. Noble will request a No Further Action (NFA) designation if the reanalyzed samples comply with the Table 915-1 concentration standard. Background samples will serve to justify elevated concentrations where applicable.

This Form 27 is being submitted as a Q2 2025 timeline update for the former OSTER 27-11G flowline location to include decommissioning results and propose a supplemental site investigation.

In accordance with COAs issued via document numbers 403649317 and 403759278, the operator returned to the former Oster 27-11G flowline on 12/11/2024. A sample was collected at the previously field-screened directional change (Sample Location FL02) and analyzed for the full Table 915-1 analyte suite. The soil analysis showed no exceedances for ECMC Table 915-1 organic compounds, Soil Suitability for Reclamation (SSRs), or metal concentrations, with results falling within the natural variability observed in the local background sample concentrations.

The operator will conduct a supplemental site investigation collecting re-samples at the FL01@5.0' and FL03@5.0' sample locations to confirm the initial analytical results and obtain metal concentration data. Please refer to the site investigation as outlined in this proposed Site Investigation Report workplan and the attached proposed Site Investigation Plan for sample locations. The Operator will complete the additional site investigation activities as outlined in the proposed Site Investigation Report workplan following the approval of this form.

Based on currently available data, this project is not affected by data integrity irregularities and is not associated with Operator's data integrity review process and its Rule 525.e. Voluntary Disclosure. As part of its data integrity review process, Operator requested the lab protect the laboratory analytical report from subsequent unauthorized modification by anyone outside the lab, which resulted in the lab reissuing the original report with additional protections (Reissued Report). The Reissued Report was received directly from the lab on March 27, 2025 and April 4, 2025, which the application of a Digital ID/Verified Certification (lock) to support reissuance. The metadata associated with this Reissued Report also includes the lab representative's name, the date and time the laboratory reissued the report, and an explanation for the report reissuance. The Reissued Report is attached to this submission.

In the event additional responsive information is received or discovered that would suggest this project should be incorporated into the ongoing data integrity review process associated with Operator's Rule 525.e. Voluntary Disclosure, Operator will update and/or amend the statements in this submission and provide any new or revised data or other information.
