 The flowlines have been abandoned on the Post-AB Form 42 Doc# 404193611.
 Form 42 was submitted prior to plugging operations, Form 42 Doc #404088258. Form 42 was submitted prior to MIRU for plugging operations, Form 42 Doc #404088250.
 Prior to placing the 632' plug, operator waited a sufficient amount of time to confirm static conditions. There was no pressure or fluid migration.
 The plug was cemented to surface with 280sacks of cement from 632' - surface with an additional 10 sks of cement at surface. At least 100' of cement was left in the wellbore for each plug.
 After cut prior to cap, Operator verified isolation by a 15 minute bubble test and no flow was observed.
 This form 6-SRA addresses all COA's from the Form 6-NOIA.
 Venting health and safety precautions were taken to avoid nuisance and or hazards to the public.
 A Bradenhead test was performed before plugging this well. No pressure was present. Form 17 submitted with results, Doc #404061935.
 Operator reviewed the stormwater program and implemented stormwater BMPs and erosion control measures as needed to prevent sediment and impacted stormwater runoff from entering the wetlands and surface water.
 Owners/Occupants of BUs were provided information regarding operators contact information and the nature, timing and duration of P&A operations.
 Due to proximity to expected shallow groundwater, operator implemented secondary containment as needed.
