The lease operator arrived on location and identified condensate pooled inside the lined secondary containment. Upon further inspection the tank failed due to rust near the bottom ring of the tank. The well was shut in, the tank was isolated, and a transport truck was dispatched to the location to recover all liquid inside the lined secondary containment.
