A site investigation was conducted pursuant to ECMC Rule 911 at the UPRC CHEWY T5N-R64W-S23 L01 Tank Battery location.

Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Metals were omitted from the initial sampling plan for the UPRC-65N64W 23SESW tank battery. To ensure the UPRC-65N64W 23SESW tank battery site complies with the full suite of ECMC Table 915-1 soil concentration standards the Operator is proposing to resample all soil sample locations collected for analysis during the 6/20/2022 sampling event and analyze each location for the full suite of Table 915-1 soil constituents.
