A site investigation was conducted pursuant to ECMC Rule 911 at the BARNARD T4N-R65W-S4 L01 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumpline(s) of any separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

The ECMC Tank Battery and Produced Water Vessel Closure Checklists were utilized and filled out during the abandonment process. A photolog was attached.

Fifteen background soil samples were collected from an area not impacted by oil and gas development and at similar depths and lithologies as confirmation soil samples collected at the location and analyzed for Table 915-1 metals and SSR constituents. Background soil sample analytical results were reported with elevated levels of pH, Arsenic (As), Barium (Ba) and Lead (Pb).

Confirmation samples collected at the AST 0.5', SEP DL 3', and PWV FLOOR 4' locations at the former Barnard-64N65W 4SWNW tank battery were submitted out of the required temperature preservation range. To validate the original analytical results, these soil locations will be re-sampled at the same depths and analyzed for the full Table 915-1 analyte suite.

If the reanalyzed sample results meet the applicable Table 915-1 concentration standards, Noble will request a No Further Action (NFA) determination for the site. In instances where concentrations exceed these standards, local background concentrations will be referenced to justify any elevated analytical results.

In addition to the confirmation resampling, background sample locations BKG01 through BKG05 will also be re-sampled to confirm initial background concentrations.
