INSP#716300702 indicated that the Givens 24-25 KV well has been plugged and abandoned but the pit permitted to this well has not been closed. ENR has decided to close the pit. Soil samples will be collected within the pit and three sites. SS2, which will be collected at the area of greatest impact, will be analyzed for full 915-1 analytes. Two other sites will be analyzed for 915-1 Soil Suitability for Reclamation and metals. A fourth sample will be collected from an area outside of the pit, and unaffected by operations to determine native arsenic levels.
