## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Delineation samples were collected on 7/2/2025. 4 of the 5 samples collected exceed pH and SAR Table 915-1 Concentration Levels. Additionally TB-FS-02 exceeds GWSSL for Barium. Groundwater was not encountered. Closest water well (Permit #62662-MW) is 2430' and depth is 40'; Magpie requests RSSL.
