A site investigation will be conducted pursuant to COGCC rule 911 at the IONE 2N66W/1QSESE (330969) oil and gas location pertaining to the cut/cap of the IONE 6-8-10 (05-123-32354) and decommission of the IONE 6-8-10 (12332354_FL) wellhead line. All other wells and equipment will remain active. See site map exhibit for details.

Background samples will be collected from homogenous soil horizons and/or corresponding excavation sample depths.
