INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared as a supplement to the approved Form 27-Initial (Document No. 403920407) which provided prior notice of the plugging and abandonment of the HSR-Creaseon 11-5 and HSR-Bell 12-5 wellheads and the permanent removal of the associated flowlines. This form has been prepared to provide prior notice of the change in scope of work to include the plugging and abandonment of the HSR-Chaknova 14-5 wellhead and the permanent removal of the associated flowline. The off-location flowline system pre-removal notices were submitted under Form 44 Document Nos. 403916966, 403916983, and 404253236. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1.

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Following wellhead cut and cap operations, soil will be field screened at the wellheads, wellhead and separator risers, and associated flowlines. A soil sample will be collected from the base of the excavation adjacent to the wellheads, adjacent to the wellhead and separator risers, and areas most likely impacted during the operational life of the flowlines and analyzed for all analytes listed in ECMC Table 915-1. Soil samples will be submitted to an accredited laboratory for analysis using standard methods appropriate for detecting the target analytes in ECMC Table 915-1. Proposed soil sample and screening locations are provided on Figures 2 and 3.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during plugging and abandonment activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for all analytes listed in ECMC Table 915-1 Organic Compounds in Groundwater and Groundwater Inorganic Parameters using standard methods appropriate for detecting the target analytes in ECMC Table 915-1.
