A site investigation was conducted pursuant to ECMC Rule 911 at the HOWARD USX T6N-R64W-S9 L03 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumpine(s) of any separator(s). Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Nine background soil samples were collected from an area not impacted by oil and gas development and at similar depths and lithologies as confirmation soil samples collected at the location and analyzed for Table 915-1 metals and SSR constituents. Background soil sample analytical results were reported with elevated levels of pH, Arsenic (As), Barium (Ba), Cadmium (Cd), Lead (Pb) and Selenium (Se).

Elevated inorganics and metals were observed in multiple locations at the former HOWARD USX T6N-R64W-S9 L03 Tank Battery. Soil will be resampled and analyzed for the full Table 915-1 analyte suite at the PWV01-E@2', SEP01-DL@2' and PWV01-B@5' sample locations at the same depth where the initial elevated concentrations were observed. Additional background samples will be collected to further native soil characterization as well. Noble will request an NFA be granted if the reanalyzed samples comply with the Table 915-1 concentration standard. Background samples will be used to justify elevated concentrations.

Alternatively, if the sample results exceed the Table 915-1 standards and cannot be attributed to native soil conditions via background soil characterization a minimum of five additional samples will be collected to delineate the magnitude and extent of elevated constituents.
