A site investigation will be conducted pursuant to COGCC rule 911 at the FOSNOT 13H-6-39-17 pit. The pit was historically back-filled by previous operator, soil samples will be taken and analyzed per Table 915-1 to ensure that this pit does not require any remediation prior to final reclamation on this location.

One grab soil sample will be collected at the highest PID field screening location in the soil bore and analyzed by a certified laboratory for TPH C6-36, organics, pH, boron, EC, and SAR.

If groundwater is encountered the soil bore will be converted to a monitoring well. A groundwater sample will be collected for analysis by a certified laboratory for BTEX, naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene.
