Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the Village 16A-DU wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules on 06/18/24. A grab soil sample (WH01 @ 6') was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation.

Two background soil samples were collected from one discrete location (BKG01) up-gradient of the former wellhead location and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, and EC. Background soil samples were collected from depths of 3 and 5 feet below ground surface (ft bgs). The maximum background concentration for pH was observed to be 9.02. The maximum background concentrations with a 1.25x multiplier applied for arsenic, barium, and lead were calculated to be 7.24 mg/kg, 153 mg/kg, and 11.5 mg/kg, respectively. All pH, arsenic, and barium concentrations observed during decommissioning were below background levels.
