INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the BETHYL GW29-12 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the BETHYL GW29-12 flowline. Approximately 710' of flowline was abandoned in place. See ECMC Form 44 Doc # 403624203.

Residual petroleum hydrocarbon impacts identified at the site were removed through excavation. Soil samples were collected for analysis of TPH C6-36, Table 915-1 organics in soil, arsenic, and barium, per supplemental Form 27 Doc. # 403655798. Soil samples were collected to confirm the vertical and lateral extents of the impacts following source removal. Results of the excavation/confirmation sampling indicate that all current organic concentrations are in compliance with ECMC Table 915-1 regulatory limits.
