INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the NOVACEK C28-27D wellhead cut and cap and flowline removal. Approximately 382' of flowline was removed on June 6, 2024. The wellhead was cut and capped per ECMC rules on May 16, 2024. Additionally, soil samples were field screened at the NE-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling was conducted on July 1, 2025.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Visual inspection of the wellhead and flowline areas occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The ECMC Flowline Closure and Wellhead Closure Checklists was utilized and filled out during the abandonment process. A detailed summary of wellhead re-sampling activities, including field notes, site photos, figures, and laboratory analytical results, is attached to this Form 27.

Six background soil samples were collected from three locations near the wellhead on July 18, 2025 and analyzed for Table 915-1 metals in soil and Soil Suitability for Reclamation parameters per ECMC Table 915-1. The background soil samples were collected from a depth of 4 and 6 feet below ground surface (ft bgs). The lithology between the site and background locations was observed to be well graded sands. Additional background samples will be collected along the flowline to determine site specific background concentrations of pH, arsenic, barium, cadmium, chromium, and selenium and at the wellhead to determine background concentrations of pH.

A supplemental site investigation (SSI) will be completed to collect additional background samples to determine if elevated levels of pH at the wellhead and pH, arsenic, barium, cadmium, chromium, and selenium at the flowline are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.
