While there, I observed that the separator lacked a wildlife screen, and weeds around the location. During this inspection the following possible compliance issues were observed: Rule 608.b.(7). with a corrective action date of 9/30/2025, Rule 606. with a corrective action date of 9/30/2025. A follow up inspection on this site needs to be conducted to ensure the compliance issues have been corrected to comply with ECMC rules.
