A site assessment will be conducted pursuant to ECMC rule 911 at the SE CAMPO UNIT 603 wellhead cut & cap and its associated offsite flowline to be abandoned in place.

Grab soil samples will be collected from the N-E-S-W sides and the floor of the of the wellhead cut/cap excavation and field screened using a PID. If impacts are not apparent from visual, olfactory, and PID screening, the floor soil sample will be submitted to Origins Laboratory in Denver, Colorado for full ECMC Table 915-1 analysis. If there are any apparent potential impacts, all 5 soil samples will be submitted to Origins for full Table 915-1 analysis. Grab background soil samples will be collected from outside of the location perimeter at similar depths and submitted to Origins for Table 915-1 Soil Suitability for Reclamation and Metals analysis.
