Comment:

The access road leading to the location and the northern hillside are not progressing towards uniform, desirable, perennial vegetation and remain predominately bare. Prickly Russian thistle was observed growing on the hillside, and cheatgrass is scattered throughout the location. Dominant reclamation species include fourwing saltbush with secondary amounts of rubber rabbitbrush, broom snakeweed, crested wheatgrass, intermediate wheatgrass and weedy annual pepperweed species. Additional reclamation efforts may be necessary to ensure that the access road and northern hillside progress towards 1004 final reclamation requirements. Ongoing weed maintenance is required until the location receives a passing final reclamation inspection.
