INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to support removal of a wellhead and off-location flowline. In accordance with COGCC Rule 911 and Rule 915, initial representative soil samples will be collected beneath the wellhead. Initial laboratory soil analysis will include only BTEX, 1,2,4 and 1,3,5 Trimethylbenzene, naphthalene, TPH, pH, EC, SAR and boron. Soil samples collected beneath the off-location flowline will be field screened, and a lab analysis submitted if impacts are identified. Groundwater, if present, will also be collected and analyzed. Identified impacts will be reported as required for each discovery, and a Form 19 will be submitted, and remedial investigation will be conducted with excavation equipment.

A site assessment will be scheduled to assess the results associated with soil sample FL02@4.3'. Soil samples will be collected for analysis of Table 915-1 organics, TPH C6-36, metals, EC, SAR, pH, and boron. A detailed reclamation plan will be developed for the wellhead location to account for concentrations of pH and SAR.
