Pioneer is requesting continued temporarily abandoned status on the Sweden 21-2 well as it is not feasible to rework the well at this time due to current market conditions. A Form 5A for temporarily abandoned status was submitted to the COGCC recently as well as a mechanical integrity test dated 5/31/2018. The well is closed to the atmosphere via a wellhead secured and shut in by a valve as well as a bridge plug set at 2,620'. The next operator will determine the future utilization of this well.
