Secondary amounts of sagebrush and rubber rabbitbrush are present throughout. Interim areas appear to be progressing towards 1003 interim reclamation requirements.

 Kochia and bindweed were observed at the location. A contractor was present at the location performing weed control during the time of the inspection.
