Comment:

Inspection conducted during the growing season. Russian wildrye and intermediate wheatgrass are dominant throughout portions of the location. The northwestern portion of the location appears to have not established well and lacks uniformity. Russian knapweed and kochia were observed to have established on the central portion of the location. Weed control is required.

A follow-up inspection will be conducted to determine compliance with 1004 reclamation standards.

Corrective Action: **Comply with Rule 606.a. and 1004.e. Ongoing weed management is required until the location receives a passing final reclamation inspection.**
