Crestone maintains a chemical program to reduce internal corrosion. If a flowline is found to lack integrity, Crestone will investigate, report, and remediate any spills in accordance with the 900 series rules.

Description of Integrity Management Program

Crestone flowlines are pressure tested prior to placing flowlines into service. Flowlines are tested on an annual basis in accordance with COGCC 1104 series rules. If a flowline is found to lack integrity, Crestone will investigate the root cause, as well as report and remediate any spills in accordance with the 900 series rules. All repairs will be completed in accordance with COGCC 1102 Series rules.

The flowline serving the ARISTOCRAT ANGUS 21-10 (05-123-09497) was originally abandoned in place due to asbestos with post-abandonment verification reported on form 44 doc #403608174. The flowline has subsequently been removed in its entirety (pre-abandonment for removal submitted on form 44 doc #403470374). Bellholes were dug on average every 80 feet and the line pulled. Once the flowline was removed, all areas that needed it were backfilled and the land surface was graded.
