Casey stating the following " The 3-phase power line that currently is on section 25, is also being used by another consumer's stock well a span south of the AU 132 power bank. And this power line is on landowner property which has a signed

easement with KC Electric. The only way we retire any powerline is with a signed removal of service affidavit from the current landowner stating they no longer want this on their property. The signed affidavit that Citation receives is just stating that they no longer need the electrical service at that location. If you have any question, feel free to contact me". Comment: ECMC Inspection 713602228 Comment:
"The electric utility line servicing the former well site has not been removed. Operator will need to coordinate removal with utility company and reclaim associated disturbance. The location is reclaimed and perennial vegetation is progressing. All other surface equipment has been removed."

Since the power pole is currently in service by another consumer and under a signed easement by the power company, it cannot be removed by Citation. Thus, Citation considers this corrective action completed since it is not part of Citation's operations or under its responsibility.
