PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Wesco will collect a minimum of 1 and maximum of 7 confirmation soil samples. One base confirmation soil sample will be collected from the base of the excavation footprint immediately adjacent to the cut and capped well. One sample will be collected from each of the four sidewalls of the open wellhead excavation for field screening purposes, if impacts are observed, the sidewalls will be submitted for laboratory analysis. Wesco will collect flowline samples from areas where the lines would have transitioned from below ground to above ground (90s), collected 6-12 inches below the 90s. One five-point composite confirmation sample will be collected from stockpiled material associated with the excavation. The five-point aliquot will be thoroughly mixed prior to field screening and jarring. A site-specific background soil sample will be collected to further establish naturally occurring soil concentrations in the area.
