Comment:	Kochia and cheatgrass have established on the working pad surface and around the wellheads; Russian knapweed was also observed within the wellhead area. Cheatgrass and kochia are dominant throughout the interim areas. Inspection #719500070 issued a Corrective Action for weed management by 06/11/2025. It was observed during this inspection that plumeless thistle was removed from around the wellheads; however, cheatgrass and kochia remain and may pose a fire hazard. Weed maintenance is required.
